As a development professional, your job is to explore every possible avenue for funding, and one of them is the government. However, when it comes to member items, also known as member initiatives, and sometimes referred to as “pork money,” many of us are a bit confused. Aside from being uncertain of what they are, how to apply for them, and whether our programs are eligible, we may also wonder if there will be any funding available given the current state budget crisis, and whether pursuing them is worth the effort.

So what is a member item? *A member item is a portion of state funding allocated by the Senate and Assembly and used for a public purpose. The annual member item allocation is divided among the two houses of the New York State Legislature pursuant to agreement with the governor. Member item allocations are discretionary. Typically, the funds are used for community projects, civic, and public health initiatives in the recipient members’ districts. Member items traditionally represent tens of millions of dollars of spending in each year’s state budget.*

No doubt, the concept of approaching your legislator for funding brings up many more questions:

- How much funding is available to my legislator?
- What are his or her personal priorities or areas of interest?
- Which programs have they supported before?
- How important is building a relationship with my legislator to receiving a grant?
- What are my organization’s chances of success without the support of a lobbyist?
- What is the process and timeline for submitting a request?
- What are the common mistakes?
